About the Position

Communications Dispatchers are responsible for receiving emergency and service request telephone calls. Incumbents begin working in this classification performing communications dispatch work in a learning capacity. Incumbents are expected to work all phases of communications center duties as experience is gained. Employees may work rotating shifts on a twenty-four hour basis, seven days a week.

About the Department

The San Joaquin County Sheriff's Department Communication Dispatch Center provides service to San Joaquin County including two contract cities, the City of Lathrop and Mountain House. There are currently 871 total positions in the Sheriff's Department including 26 Communications Dispatcher I/II, 6 Communications Dispatcher III, 6 Communication Dispatcher IV and a Communications Dispatch Manager. Communications Dispatcher I Typical Duties

- •Receives, evaluates and prioritizes 911 calls for services; elicits information necessary to identify problem and evaluate the urgency and seriousness of the problem; determines the appropriate action; completes call form for dispatching purposes.
- •Operates a Computer Aided Dispatch (CAD) terminal to enter calls for service and to dispatch the appropriate units for the Sheriff's Department, other law enforcement agencies and fire districts which serve the San Joaquin County area; contacts ambulance companies to dispatch their emergency vehicles accordingly.
- •Ensures facility security through the operation of all entry and exit doors and sallyports for both the perimeter and interior jail zones.
- •Operates various office equipment including multi-channel computerized radio system and multi-line computerized telephone system; operate keyboards and computer terminals.
- •Assists callers in emergency situations by informing them of lifesaving procedures until help arrives.
- •May perform general clerical duties as required.

Communications Dispatcher II Typical Duties

- •Receives and acknowledges calls on radio equipment and phones; screens incoming calls to elicit information necessary to identify problem, to evaluate the urgency and seriousness of the problem and to determine the appropriate action.
- •Receives and processes requests for information from units; obtains information using data entry equipment, communications equipment or card files and relays information back to units.
- •Dispatches vehicles in response to requests; identifies the most available unit or units which can be contacted; contacts mobile units and directs them to location and person.
- •Contacts ambulances, fire departments and other agencies to dispatch vehicles in emergency situations.
- •Monitors and logs status and location of each mobile unit.
- •Operates CRT terminal to maintain communications log and transmit information to local, state and national law enforcement communications system.
- •Does general clerical work; updates fire dispatch run card files.

Experience: Six months performing journey level clerical work or operating multi-line telephone or radio communications systems.

OR II

<u>Education</u>: Completion of 30 semester units from an accredited college or university.

OR III

Experience: One year of experience working in a law enforcement environment.

Communications Dispatcher II also Requires

<u>Certificate</u>: Possession of a valid POST "Public Safety Dispatcher" Certificate.

Note: Candidates must be able to successfully pass a background investigation conducted by the Sheriff's Office to be considered for this position. Background requires attending an orientation, submitting a personal history statement and drug screening.
