#### THE POSITION

San Joaquin General Hospital is seeking a Trauma QI Nurse to perform responsible program development and coordination of the Trauma Department's quality improvement program in collaboration with the Trauma Program manager and medical director. This key position will organize, implement, monitor and maintain the department's quality and performance improvement processes which include quality improvement functions and activities of medical and nursing staff as well as ancillary departments of the hospital.

As a Level III Trauma Center, our specially-trained team of experts is ready to provide optimal care for the injured patient 24-hours a day. The trauma team consists of dedicated Emergency Physicians, Trauma Surgeons, specially trained trauma nurses, intensive care nurses, emergency department nurses, and respiratory and radiology technicians. In a county of 700,000+ people, San Joaquin General Hospital's Trauma Team cares for about 1,200 patients a year as the region's dedicated Trauma Center.

The ideal candidate should possess familiarity with trauma activation codes; be technologically savvy; have an ability to work collaboratively; and build and maintain effective working relationships with committees, healthcare staff, external agencies, and the general public. Candidates should also possess the following skills and abilities: an ability to abstract and analyze data; demonstrated change management skills; strong verbal and written communication, presentation, and interpersonal skills.

#### SAN JOAQUIN GENERAL HOSPITAL

San Joaquin General Hospital, originally established in 1857, is a 196-bed general acute care facility providing a full range of both inpatient and outpatient services. In addition to providing direct medical services, the hospital is active in providing education for health professionals through post-graduate residency programs in General Surgery, Internal Medicine and Family Practice and has trained over 3,000 physicians since the residency programs were established in 1932. The hospital also participates in clinical affiliation agreements for training programs in a variety of health professions.

#### TYPICAL DUTIES

The typical duties include but are not limited to the following:

- Performs highly skilled, clinical patient care; participates in preparation and implementation of written nursing care plans for individual patients; evaluates the total nursing needs of the patient; participates in planning, coordinating, and administering total patient care; coordinates follow up of incidents and quality of care issues; participates in rounds and case reviews.
- Implements and interprets standards of care for trauma patients; assists in the development of treatment protocols and guidelines to improve the quality of care of trauma patients; communicates and records assessments, nursing diagnoses, interventions, and evaluations of patient's progress using nursing care plans; maintains a safe, therapeutic environment for patients.
- May participate in the identification of staff development and performance improvement needs for members of hospital staff involved in the care of trauma patients; assesses and improves departmental performance; participates in the evaluation process.
- Keeps records of patient's health care treatment and/or hospital stay; prepares reports and standard forms; initiates and completes performance improvement and other studies in cooperation with the Deputy Director of Trauma; develops, plans, organizes, coordinates, implements, and reviews the quality improvement plan for the Trauma Department; assists with data collection.
- May assume full responsibility for the supervision of a unit or shift in the absence of the Deputy Director of Trauma; may supervise and assist nursing personnel in the performance of patient care.

#### **TYPICAL DUTIES, cont.**

- Participates on committees as assigned; may represent the department to outside organizations.
- Prepares and presents projects as assigned; consults and coordinates projects with other divisions as needed; initiates and completes studies in cooperation with the Deputy Director-Trauma; facilitates the measurement of selected outcomes for the trauma patient population.

#### **IDEAL CANDIDATE**

The department is seeking a candidate who not only possesses nursing experience in a trauma department but also has a familiarity with quality improvement programs and processes. candidate will have strong analytical skills, strategic and critical thinking skills, initiative, excellent communication skills, and strong interpersonal skills. Because this position will require working with multidisciplinary providers, departments, and agencies internal and external to the organization in order to assess and improve trauma patient outcomes, the ideal candidate must excel at creating and maintaining a collaborative working relationship. The ability to abstract and analyze data will require candidates to be proficient in trauma registrar data programs/software in order to abstract and analyze the data, and prepare graphs and other reports based upon the information gathered.

<u>Certification</u>: Current Trauma Nursing Core Course (TNCC), ACLS, and BLS. The following certifications are <u>desirable</u>: 1) Lean Six Sigma Green Belt or comparable QI certification or training, and 2) Certified Professional in Healthcare Quality (CPHQ).

<u>Education</u>: Possession of a Bachelor's degree in Nursing is preferred.

<u>Special Requirement</u>: Hire is contingent upon successfully passing a pre-employment physical exam and drug screening.
