The Department

The Agricultural Commissioner enforces the provisions of the California Food and Agricultural Code for the protection of the public's health, safety and welfare, and promotes and protects the agricultural industry. The department consists of two divisions: Agricultural Commissioner and Weights and Measures. The Agricultural Commissioner Division promotes and protects the County's agricultural interests while protecting the public health and environment. The Division enforces pesticide use and worker safety regulations and quarantine regulations and performs pest detection, pest management and pest eradication activities. The Agricultural Commissioner prepares the County's annual agricultural report which is provided to the Board of Supervisors, growers, food processors, libraries, businesses, schools and other interested parties.

The Division of Weights and Measures protects consumers and businesses by promoting fairness and equity in the marketplace with the enforcement of the California Business and Professions Code and other State and County laws and regulations. Areas of enforcement by the Division are: Weighing and Measuring Devices, Petroleum Products, Weighmaster, and Package Labeling Quantity Control.

The department's budget for the 2022-2023 fiscal year is \$8.5 million. There are 43 full-time employees and a number of seasonal employees throughout the year.

The position will work closely with other County departments, officials, outside agencies, regulatory agencies, and the public and will be responsible for fostering cooperative working relationships. This position carries out State programs under the administration of the California Secretary of Food and Agriculture.

Compensation and Benefits

Annual Base Salary: \$139,075- \$169,046*

*Annual base salary is pending approval by the County Board of Supervisors on August 9, 2022.

In addition to the base salary, the County offers a Cafeteria Plan in the annual amount of \$24,023 which is considered the employer's benefit contribution and may be used to purchase medical, dental, and vision coverage.

Depending on the health plan selected, premiums not paid by the Cafeteria Plan allowance will be the employee's responsibility through a pre-tax deduction. Unused monies are paid as additional salary.

- Vacation cash-out up to 15 days annually

<u>Special Requirement</u>: Possession of valid licenses as both a County Agricultural Commissioner and a County Sealer of Weights and Measures, issued by the California Department of Food and Agriculture.

Supplemental Questions

In addition to the standard application, responses to the following questions will be required:

- Provide an overview of your management-level experience in a public agency performing Agricultural and/or weights and measures related projects. Include the programs and operations for which you were responsible.
- * Describe your experience analyzing current and potential legislation and your experience working with representatives from local and state agencies as well as law makers in State and Federal Government.
- Provide an example of a creative and innovative solution or improvement you suggested that is still being used today.

Selection Process

If warranted by the number of candidates, applications may be reviewed by a screening panel. If utilized, the screening panel will select those most qualified to be considered for participation in the selection process.

Final candidates will be invited to closed session selection interviews with the Board of Supervisors.

Offer of employment will be conditional upon successfully passing a pre-employment background, DOJ Live Scan, and drug screen.

This position is exempt from the San Joaquin County Civil Service system. Appointments to exempt positions are at-will and are not governed by the Civil Service Rules.

Agriculture

The county is one of the most agriculturally rich regions in California. Almonds are the leading commodity with over 104,000 bearing acres. Milk, grapes, walnuts, and cherries round out the top crops, with an abundance of other produce. Grapes make up 91,000 bearing acres, much of which are wine grapes. There are over 85 wineries within the Lodi Appellation offer opportunities for tasting and special events.

Weekly farmers markets throughout the county offer a cornucopia of fresh fruit and vegetables. Fruit stands and pick-your-own produce farms dot the countryside.

Housing

Housing is plentiful in San Joaquin County and is affordable when compared to other nearby areas.
