 necessary to help lead a dynamic, responsive Office of Emergency
 Services that protects and serves the residents of San Joaquin County.
- We are seeking a collaborative and decisive leader who can support
 the Director in overseeing day-to-day operations, including staff
 development, program administration, and budget oversight. The
 successful candidate will be adept at developing and implementing
 countywide emergency operations plans that meet federal, state, and
 local requirements, and ensure a coordinated response to a wide range
 of potential disaster scenarios.
- Advanced knowledge in the Incident Command System (ICS), the Standard Emergency Management System (SEMS), and the National Incident Management System (NIMS) is expected. Experience with emergency communications systems is highly desirable.

PRIMARY RESPONSIBLITIES

- Assists with the development and management of staff, programs, budgets and operations of the Office Emergency Services.
- Assists with the development of countywide non-medical emergency operations plans and procedures, coordinates with other county departments as well as with various State, Federal, city, special district, and community-based organizations.
- Assists with establishing quality control and quality improvement programs and initiatives for assigned functions and areas; develops and coordinates drills and other methods of testing for and verifying departmental and countywide emergency readiness.
- Maintains the County's Emergency Operations Center (EOC) and ensures its readiness for emergency response at all times; directs the purchase of required equipment and supplies; plans for and prepares for EOC staffing; develops and presents trainings.
- Researches and recommends grant and special funding opportunities; drafts and recommends the submission of funding proposals and applications; administers grants and programs in accordance with funding requirements; drafts and recommends the Office of Emergency budget.
- Analyzes and summarizes complex narrative information and statistical data; prepares or supervises the preparation of reports for County management as well as state, federal or other external agencies.

DESIRABLE QUALIFICATIONS

Candidates invited to participate in the screening and selection process will possess a combination of education and experience comparable to:

Education: Graduation from an accredited four-year university with a degree in business administration, public administration, public safety or related field.

Experience: Four years of management experience in Emergency planning/operations or civil defense. Experience in emergency communications and mobile radio communications/operations maintenance is highly desirable.


ARTS, CULTURE, AND RECREATION

The arts and culture provide a much-needed respite from everyday worries and the Haggin Museum, San Joaquin County Historical Museum, and Stockton Children's Museum are popular spots.

The Stockton Symphony, San Joaquin County Ballet, and Stockton Civic Theater provide important experiences for children and adults. The multi-cultural community offers a diversity of views and opinions in its art and culture, providing a wealth of knowledge about past and present on canvas and stage.

Over 75 languages are spoken within the region and there is richness in the blending of cultures and ways that creates an air of celebration about individual customs, foods and cultures. San Joaquin County government provides nine community parks for boating, camping, and picnicking, swimming and organized sports. Annual family events include the Asparagus Festival, attended by thousands of fun-seekers from the County and beyond.

Individual cities and communities provide a host of other opportunities, from Lodi Lake Park and Nature Area to the Woodbridge Ecological Reserve. The County-owned and operated Micke Grove Park offers a zoo, rides and a historical museum to delight both children and adults. The San Joaquin Delta is one of the area's best kept secrets and offers some of the best boating in the state: more than 1,000 miles of waterways stretching from the Stockton Harbor to north of Sacramento and offering access to the San Francisco Bay.



HOUSING

Housing is plentiful in San Joaquin County and is affordable when compared to other nearby areas.

Housing ranges from new developments to historic homes found mostly in central Stockton and downtown Lodi. San Joaquin County is a place where families can grow, learn, and experience the nature and beauty of the California landscape while benefiting from the unique opportunities - cultural, recreational, and educational - that the area provides.

EDUCATION

From preschool to higher education, the County has it covered with an abundant array of public or private opportunities to learn and grow. There are over 85 wineries with over 125 different varietals represented within the Lodi Appellation offering opportunities for tasting and special events.

Weekly farmers markets throughout the county offer a cornucopia of fresh fruit and vegetables. Fruit stands and pick-your-own produce farms dot the countryside.
