## About the position

The San Joaquin County District Attorney's office is seeking an experienced investigator to fill the vital leadership position of Chief District Attorney Investigator. Serving as the Chief Investigator of the Bureau of Investigations, they will report directly to the District Attorney. The Chief performs administrative and supervisory work in directing the investigative functions of the District Attorney's Office. The Chief Investigator is responsible for planning, coordinating, and supervising the District Attorney Investigators assigned to the Bureau.

## The ideal Candidate

In addition to felony investigations experience, the ideal Chief District Attorney Investigator candidate will possess strong leadership qualities and the capability to effectively direct subordinates in a large division. This position requires the ability to establish and maintain effective working relationships with other law enforcement officials as well as the public. The Chief should have advanced knowledge of civil and criminal laws; techniques, methods, and procedures of crime detection and criminal investigation; and rules of evidence, arrest and court proceedings.

### **Agriculture**

The county is one of the most agriculturally rich regions in California. Grapes are the leading commodity, with 98,000 bearing acres, much of that in wine grapes. Over 85 wineries within the Lodi Appellation offer opportunities for tasting and special events.

Almonds, walnuts, tomatoes and cherries round out the top crops, with an abundance of other produce. Weekly farmers markets throughout the county offer a cornucopia of fresh fruit and vegetables. Fruit stands and pick-your-own produce farms dot the countryside.

Housing ranges from new developments to historic homes found mostly in central Stockton and downtown Lodi. ## **Typical Duties**

An employee in this exempt class is responsible for planning, coordinating, and supervising the activities of the investigators assigned to the District Attorney's Office.

- Plans, organizes and directs the investigative activities of the District Attorney's Office.
- Consults and confers with department management staff in the formulation of investigative plans, policies and procedures.
- Reviews and evaluates reports on cases investigated; insures that complete reports are submitted; advises the District Attorney as to course of action to be taken.
- Coordinates the investigative activities of the District Attorney's Office with local, state, and federal law enforcement agencies; establishes liaison with other public agencies.
- Enforces all criminal and civil laws falling within the scope and jurisdiction of the District Attorney in the prescribed conduct of the office.
- Selects and trains investigative staff; prepares employee performance evaluations; recommends disciplinary action, promotions, transfers, and merit increases.
- Directs the compilation and maintenance of records; prepares reports and correspondence.
- Conducts or participates in meetings and conferences as a representative of the District Attorney's Office.
- Assists attorneys in court or in the presentation of evidence; may testify in court.

## **Minimum Qualifications**

#### **EITHER PATTERN I**

Experience: Four years of experience as a District Attorney Investigator II in San Joaquin County service.

#### **OR PATTERN II**

<u>Experience</u>: Six years of experience as a peace officer performing felony investigations in an investigative unit of a public law enforcement agency.

#### <u>AND</u>

<u>License:</u> Possession of a valid California driver's license.

<u>Certification</u>: Possession of an Advanced P.O.S.T. Certificate including or supplemented by successful completion of approved courses in Powers of Arrest and use of firearms in accordance with Penal Code Section 832. Such courses must have been approved by the CA Commission of Peace Officers Standards.
