## **Typical Duties**

- Plans and develops a mental health program for mentally ill, disabled or emotionally handicapped clients.
- Conducts and participates in staff meetings to insure effective coordination of work; hires, trains and evaluates staff.
- Selects, assigns, supervises and evaluates subordinate professional and para-professional personnel in the performance of social casework, and in recording case histories and related matters.
- Assigns cases and assists subordinates with difficult cases.
- Prepares program budget; prepares and maintains records, reports and correspondences; may requisition supplies.
- Consults with and informs medical personnel and other staff members of matters relating to social and environmental problems of clients and their families.
- Participates in the planning and conducting of training programs teaching diagnosis and treatment methods.
- Coordinates the social work program with related community social services and treatment facilities.
- Supervises and participates in interdisciplinary diagnostic and dispositional conferences to determine the nature of illness and recommend treatment plans; performs clinical assessments; makes pre-release studies of cases and makes recommendations accordingly.
- Determines, interprets and implements policies and procedures; monitors program effectiveness.
- Serves as an advocate for the civil and service rights of clients and family members.

## **Minimum Qualifications**
