About the Position

Communications Dispatchers are responsible for receiving emergency and service request telephone calls. Incumbents begin working in this classification performing communications dispatch work in a learning capacity. Incumbents are expected to work all phases of communications center duties as experience is gained. Employees may work rotating shifts on a twenty-four hour basis, seven days a week.

About the Department

The San Joaquin County Sheriff's Department Communication Dispatch Center provides service to San Joaquin County including one contract city, the City of Lathrop and one community service district, Mountain House. There are currently 878 total positions in the Sheriff's Department including 21 Communications Dispatcher I/II, 6 Communications Dispatcher III, and 6 Communication Dispatcher IV. Hiring Incentive Program

Over 75 languages are spoken within the region and there is richness in the blending of cultures and ways that creates an air of celebration about individual customs, foods and cultures.

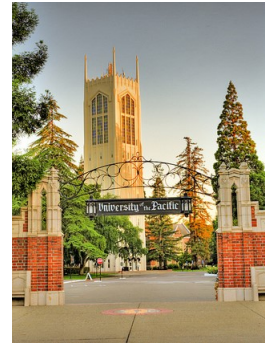
San Joaquin County government provides nine community parks for boating, camping, and picnicking, swimming and organized sports. Annual family events include the Asparagus Festival, attended by thousands of fun-seekers from the County and beyond.

Individual cities and communities provide a host of other opportunities, from Lodi Lake Park and Nature Area to the Woodbridge Ecological Reserve. The County-owned and operated Micke Grove Park offers a zoo, rides and a historical museum to delight both children and adults. The San Joaquin Delta is one of the area's best kept secrets and offers some of the best boating in the state: more than 1,000 miles of waterways stretching from the Stockton Harbor to north of Sacramento and offering access to the San Francisco Bay.



Education

From preschool to higher education, the County has it covered with an abundant array of public or private opportunities to learn and grow. The University of the Pacific, California State University, Stanislaus-Stockton Center, Humphreys College and Law School, National University, and the San Joaquin Delta Community College offer a wide variety of choices for educational opportunities. The County's 17 school districts provide families with a wide choice for children's educational development.



Agriculture

The county is one of the most agriculturally rich regions in California. Grapes are the leading commodity, with 98,000 bearing acres, much of that in wine grapes. Over 85 wineries within the Lodi Appellation offer opportunities for tasting and special events.

Almonds, walnuts, tomatoes and cherries round out the top crops, with an abundance of other produce. Weekly farmers markets throughout the county offer a cornucopia of fresh fruit and vegetables. Fruit stands and pick-your-own produce farms dot the countryside.

Housing

Housing is plentiful in San Joaquin County and is affordable when compared to other nearby areas.

Housing ranges from new developments to historic homes found mostly in central Stockton and downtown Lodi. Communications Dispatcher I

Typical Duties

- Receives, evaluates and prioritizes 911 calls for services; elicits information necessary to identify problem and evaluate the urgency and seriousness of the problem; determines the appropriate action; completes call form for dispatching purposes.
- Operates a Computer Aided Dispatch (CAD) terminal to enter calls for service and to dispatch the appropriate units for the Sheriff's Department, other law enforcement agencies and fire districts which serve the San Joaquin County area; contacts ambulance companies to dispatch their emergency vehicles accordingly.
- Ensures facility security through the operation of all entry and exit doors and sally ports for both the perimeter and interior jail zones.
- Operates various office equipment including multi-channel computerized radio system and multi-line computerized telephone system; operate keyboards and computer terminals.
- Assists callers in emergency situations by informing them of lifesaving procedures until help arrives.
- May perform general clerical duties as required.

Minimum Qualifications

Communications Dispatcher I:

Either I

Experience: Six months performing journey level clerical work or operating multi-line telephone or radio communications systems.

OR II

Education: Completion of 30 semester units from an accredited college or university.

OR III

Experience: One year of experience working in a law enforcement environment.

Note: Candidates must be able to successfully pass a background investigation conducted by the Sheriff's Office to be considered for this position. Background requires attending an orientation, submitting a personal history statement and pre-employment drug screening.

Application and Selection

The competitive process includes submittal of a completed San Joaquin County Employment application and Supplemental Questionnaire. Resumes will not be accepted in lieu of a complete application package. Qualified candidates will be invited to participate in a written exam. Those that pass the exam will be forwarded to the Sheriff's Office for hiring consideration.

Candidates may provide POST Entry-Level Dispatcher Selection Test T-scores from other agencies in lieu of taking the written examination. T-Scores must be provided on agency letterhead for an exam administered within the last 12 months. A T-Score of 48 or higher is qualifying with San Joaquin County.
