THE POSITION

The San Joaquin County Public Works Department is seeking a strong manager to

Reporting to the Integrated Waste Manager, the Engineer V heads the Solid Waste Division's engineering section. This section is comprised of three staff members plus the Engineer V.

The position will plan and organize all engineering-related activities of the Solid Waste Division, including:

- Long-term planning for the development of County-owned Solid Waste facilities, including disposal, recycling and organics processing
- Procuring consultants and managing construction contracts to develop additional landfill areas as needed in implementation of long-term facility development
- Providing technical support to County's Resident Engineer during construction of Solid Waste Division facilities
- Administering on-call contracts as may be needed to supplement section staff
- Regulatory compliance at County-owned solid waste facilities, and interaction with regulatory agencies to address issues
- Developing the North County Sanitary Landfill fill plan, and supporting Operations staff in using GPS to guide refuse placement
- Preparing budgets related to the above
- Monitoring new legislation for new requirements as may apply to the County

An ideal candidate will have:

- Experience in successful interaction with relevant regulatory agencies and agencies' staff, in particular with Regional Water Quality Control Boards, and especially with the Central Valley Regional Water Quality Control Board
- Experience with the design and construction of sanitary landfills in compliance with California and related Federal regulations
- Understanding of technical issues related to solid waste facilities, including liner design, leachate collection, groundwater protection and landfill gas control
- Excellent written and verbal communication skills
- Ability to work well with subordinate staff, peer professionals, and senior Department administrators
- Demonstrated leadership skills, sound judgment and a positive attitude to effectively manage and build consensus among staff, and to motivate staff and support their professional development

## THE DIVISION

The Solid Waste Division is responsible for solid waste and diversion activities in San Joaquin County, including the administration of refuse collection contracts that serve citizens in unincorporated County areas, recycling programs and public outreach related to regional solid waste related environmental issues.

The Solid Waste Division administers the following facilities:

- North County Recycling Center and Sanitary Landfill (operated by County staff)
- Foothill Sanitary Landfill (operated under contract with a private firm)
- The Lovelace Materials Recovery Facility and Transfer Station (operated by County staff)
- San Joaquin County Household Hazardous Waste Facility (operated under contract with a private firm)

This division is funded primarily by an enterprise fund with revenues derived from fees paid by users of Solid Waste facilities.

## TYPICAL DUTIES

The Engineer V in the Solid Waste Division will act to ensure the Division performs in a manner consistent with the overall strategic direction of the Typical duties will include, but are not limited to:

- Supervising and directing subordinate engineering, administrative and technical personnel in the planning, development, design and construction of a variety of solid waste projects and activities
- Preparing Board Packages for applicable items that require the San Joaquin County Board of Supervisors' approval
- Ensuring regulatory compliance of solid waste facilities through inspection and monitoring by section staff and consultants, including assigning and participating in field work
- Addressing issues related to the continued operation of landfill gas collection and emissions control systems, leachate collection-and-return systems and groundwater monitoring facilities
- In coordination with other Department staff, providing the technical basis to obtain contracts for (1) the construction and expansion of solid waste facilities, and (2) engineering firms with expertise in design and construction quality insurance for landfill expansion projects
- Reviewing and approving plans, specifications, and cost estimates for Solid Waste Division construction projects
- Preparing periodic reports to the regulatory agencies including the Central Valley Regional Quality Control Board, San Joaquin Valley Unified Air Quality Management District, the San Joaquin County Environmental Health Division which acts as local enforcement for CalRecycle, and the California Air Resources Board
- Monitoring and coordinating with the operating contractor of the Foothill Sanitary Landfill
