- Serves as project leader on information systems projects; analyzes client information system needs; recommends solutions and appropriate technology to meet client needs.
- Designs project and resource plans and schedules; develops proposals using cost/ benefit analyses; oversees the installation and evaluation of software and hardware; directs members of the project team; provides written reports and presentations on project status.
- Consults, confers and coordinates activities with users, staff from various departments, outside agencies and vendors to resolve program, system, operational and procedural problems; analyzes problems and recommends corrective action.
- Assumes responsibility for developing, directing and ensuring operational availability and security of the County's most complex and strategic operations including networked and database systems.
- Performs comprehensive systems analysis to design and develop new systems and enhancements to current systems.
- Serves as technical resource in architecting wide area network and Internet/Intranet growth that supports the County's strategic direction.
- Serves as technical advisor for data planning, modeling, conceptual and physical design of database entities; updates and maintains County data dictionary.
- Performs technical writing duties in the development and production of highly complex system documentation, instructional and procedural manuals.

Minimum Qualifications

EITHER PATTERN I

Experience: One year as an Information Systems Analyst IV in San Joaquin County.

OR PATTERN II

Education: Graduation from an accredited four-year college or university with a major in computer science, information systems, mathematics, business administration or a related field.

Experience: Four years of increasingly responsible professional, analytical computer and related systems work in an information systems environment.

Substitution #1: Possession of an approved information systems technology certificate, or completion of an approved information systems training course may substitute for all or part of the above required education. A <u>list</u> of approved certificates and/or courses shall be maintained within the Human Resources Department.
