### The Position

The Office of Emergency Services is seeking an experienced coordinator to partner with County representatives, established wildfire mitigation groups (fire safe councils), the California Fire Safe Council Regional Coordinators, local fire agencies, and landowner/management agencies to build a coordinated, Countywide wildfire mitigation strategy.

This 18-month grant funded position will work toward educating, encouraging, and developing countywide collaboration and coordination among the wildfire mitigation groups and improving overall wildfire resiliency strategies and communication preparedness. Additionally, this position will serve as a liaison and establish relationships between the existing wildfire mitigation groups and County emergency management officials in an effort to establish fire mitigation projects, source and assist with Countywide wildfire grant applications, and perform outreach and wildfire awareness communication across the County.
