The Deputy Director—Purchasing and Support Services is responsible for leading, managing, and administering the programs and operations of the Purchasing and Support Services Division and reports to the Director of Purchasing and Support Services. The ideal candidate will demonstrate an innovative, effective, and fiscally sound approach to procurement functions throughout the organization; will be an effective problem solver and demonstrate the ability to manage administrative and operational challenges; demonstrate a strategic approach to the organization's objectives and possess excellent oral and written communication skills.

The Division

Purchasing and Support Services is an Internal Services Fund division of the County Administrator's Office and provides vital central support services to County departments for procurement of goods, materials and services, mail room, duplicating, records management and recycling functions as well as disposition of surplus of County property. The division consists of 25 full-time employees and four part-time employees and has a budget of approximately \$4.2 million for Fiscal Year 21-22. The Division also administers four internal service fund programs with approximate annual expenditures totaling \$4.2 million.

Our mission is to ensure the most value for the taxpayer's dollars by providing consistent, high-quality, and professional services that are timely, transparent, fair, and honest, while treating all parties with respect and dignity, and providing a high level of customer service.

- Through subordinate managers and supervisor, plans, organizes and directs the work of purchasing staff; reviews staff work to ensure accuracy, legal correctness, prices and acceptability of items to specifications; provides training in laws, ordinances and regulations governing county procurement.
- Performs more difficult purchasing tasks requiring considerable knowledge of general and specialized commodity areas.
- Confers with department officials to determine purchasing needs and advised on purchasing activities and programs.
- Assists with developing an administering the departmental budget.
