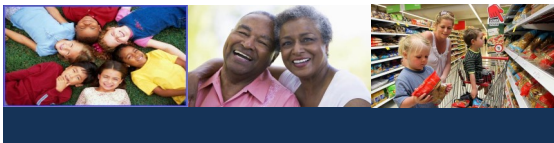

### THE POSITION

The Community Services Program Manager is a middle management position and reports directly to the Deputy Director of Aging and Community Services and is responsible for performing managerial and complex administrative work in the planning and directing of a variety of community-based services designed to promote the physical, social, and economic health of low-income individuals and families. This position is responsible for overseeing the HEAP, Wx and Commodities. Desirable candidates will possess experience in Contract Management, tracking expenditures from the different funding sources and overseeing overall operations.

Typical duties include the following:

- ◆ Plans, organizes, directs and coordinates the work of staff administering community service programs.
- ◆ Analyzes policies and procedures which apply to community service programs; interprets and communicates policies and procedures to staff.
- ◆ Plans, develops, and recommends changes to increase program effectiveness; supervises research and studies for program evaluation and interpretation.
- ◆ Evaluates staff performance; recommends and coordinates training for staff development.
- ◆ Evaluates programs, policies, and procedures; develops and implements changes in methods and policies to improve effectiveness and meet community needs.
- ◆ Acts as liaison with local and state agencies; may address public and private groups relative to community service programs; may participate in conferences or seminars.
- ◆ Prepares and reviews correspondence and reports and other materials.
- ◆ Monitors and assists in the preparation of the program budget.
- ◆ Works with Advisory Boards.
