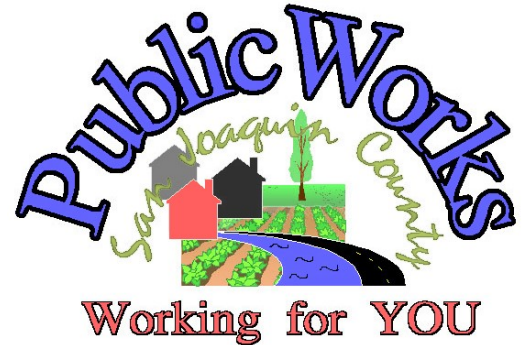


# San Joaquin County Employment Opportunity

## **Engineer V—Water Resources** **Department of Public Works**

### About the Position

The Department of Public Works (Department) is seeking a dynamic individual to fill a senior level engineering position (Engineer V) in the Water Resources Division. The successful candidate will work directly with the Water Resources Manager on current and future flood control and water supply efforts. The Engineer V will assist the Water Resources Manager with storm water and flood plain management programs; serve as project manager for complex flood and water related projects; mentor and supervise engineering staff; and recommend positions on key state and federal water policies that impact the department and community.



### About the Department

The Department has over 400 employees who are responsible for planning, designing, constructing, operating, and maintaining the County's public roads and bridges, public utility systems (water, wastewater, storm drainage, and streetlights), flood control facilities, solid waste facilities, and fleet vehicles. The Department provides quality service to the community to protect the health and welfare of the public and preserve the County's infrastructure investments. The Department's vision is being a leader in identifying and adopting processes that result in efficient and effective service to County constituents. The Department continues its mission to create a strategic outlook that leverages innovation in processes and technology; enhances fiscal transparency and accountability; invests in staff development; and fosters partnership with the community.

### The Ideal Candidate

The Engineer V is expected to work independently, with general direction from the Water Resources Manager. The ideal candidate will possess strong technical and managerial skills in planning, design and administration of storm water, flood plain and water resource projects/programs. The successful candidate shall possess excellent interpersonal/communication skills to effectively manage relationships with consultant design teams and provide informed recommendations to the Water Resources Manager. Additionally, the ideal candidate will disseminate information appropriate to the target audience, including the general public; public works administration; federal and state flood management agencies; and elected officials.

## Typical Duties

- Supervises and directs subordinate engineering, administrative and technical personnel in the planning, development, design and construction of a variety of public works projects and programs.
- Reviews and approves plans, specifications, and cost estimates for a variety of construction projects; plans and conducts feasibility studies for a variety of projects including water, flood control, drainage, traffic, road, and bridge projects.
- Consults with management and administration regarding the establishment of engineering policies and procedures in the department and for the County; recommends establishment of division policies, procedures, training and related activities.
- Confers with, advises and supervises engineers in charge of projects; supervises enforcement of contractual obligations; coordinates a variety of Public Works projects with other agencies.
- Gives technical engineering advice and may confer with other County officials, department heads, colleagues and contractors as directed.
- Represents the department and acts as liaison with other governmental agencies, contractors, and the public regarding general engineering matters and problems; may attend Planning Commission or other meetings.
- Prepares ordinances and resolutions regarding Public Works functions for action by the Board of Supervisors.
- Assists in the preparation and administration of department budgets, as assigned.

## Major Responsibilities

1. Participate and coordinate agency involvement in large, regional flood and water management infrastructure planning with local partners, and state and federal agencies.
2. Lead flood plain and stormwater planning, management and engineering activities, including current planning and development services to apply agency standards, ordinances and requirements. Interpret and apply related state and federal requirements.
3. Coordinates staff and consultants as necessary for complex investigations, engineering feasibility studies, project formulation, preparation of engineering plans and specifications, or other documents as required; monitors consultant contract provisions; recommends and develops changes as appropriate.
4. Mentor and lead a professional staff with collaborative, supervisory and managerial skills.
5. Ability to identify and solve complex problems by conferring with customers, coworkers, consultants, contractors, industry experts and others regarding project and/or program requirements.
6. Familiarity with state and federal flood management and emergency response programs, policies and agencies such as NFIP, CRS, FEMA, USACE, RWQCB/SWRCB and DWR.

The competitive process includes submittal of a completed San Joaquin County Employment application and Supplemental Questionnaire. Resumes will not be accepted in lieu of a complete application package. Human Resources will only be accepting online application submittals for this recruitment. Paper application submittals will not be considered or accepted.

The first review of qualified applications will be on October 2, 2020. Qualified candidates will be referred to the department for a hiring selection process.

Note: Final appointment will be conditional upon passing a pre-employment drug screen.

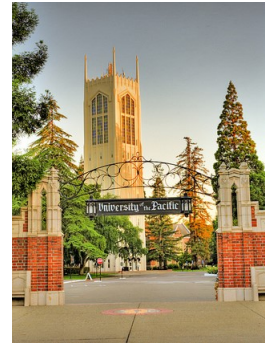

## Education

From preschool to higher education, the County has it covered with an abundant array of public or private opportunities to learn and grow. The University of the Pacific, California State University, Stanislaus-Stockton Center, Humphreys College and Law School, National University, and the San Joaquin Delta Community College offer a wide variety of choices for educational opportunities. The County's 17 school districts provide families with a wide choice for children's educational development.



## Agriculture

The county is one of the most agriculturally rich regions in California. Grapes are the leading commodity, with 98,000 bearing acres, much of that in wine grapes. Over 85 wineries within the Lodi Appellation offer opportunities for tasting and special events.

Almonds, walnuts, tomatoes and cherries round out the top crops, with an abundance of other produce. Weekly farmers markets throughout the county offer a cornucopia of fresh fruit and vegetables. Fruit stands and pick-your-own produce farms dot the countryside.

Housing is plentiful in San Joaquin County and is affordable when compared to other nearby areas.

Housing ranges from new developments to historic homes found mostly in central Stockton and downtown Lodi.
